**DOH-ACCREDITED
 MASSAGE THERAPY LICENSURE COURSE**

Prepare for the December 7, 2011 Licensure Examinations!

REGISTRATION REQUIREMENTS. You must appear in person, register, and pay the course fee in full at the HiHiP Center. You must submit a true copy of your high school diploma, transcript of grades, proof of training and educational attainments, two (2) recent passport-sized photos, updated NBI clearance. Sections are limited to 15 students. You must have a capacity for comprehension, retention, and analytical thinking. Above all, you must have a strong determination to pass the DOH licensure exams.

COURSE COVERAGE. The course shall cover the following subjects insofar as they are relevant to massage therapy: General and Organ System Anatomy and Physiology, General Pathology and Microbiology, Introduction to Massage Therapy, Massage Therapy Application, and the Practice of Massage Therapy.

UNIT TESTS, FINAL EXAM, AND PRACTICAL ASSESSMENT. During the course, you will be given written Unit Tests, a Final (qualifying) Exam, and an Oral-Practical Assessment. All of these shall be administered at the HiHiP Resource Center in Santa Rosa, Laguna.

QUALIFICATION FOR LICENSURE. You must attend all hands-on training and pass the Final Exam given by HiHiP before you can receive the *Certificate of Training* which is a requirement for you to apply for the DOH licensure examinations to be held in December. If you do not pass the HiHiP exams, you shall be given a *Certificate of Attendance* instead.

REPEATERS. If you have a *Certificate of Attendance* from HiHiP, and you wish to take the coming DOH licensure exams, you do not need to re-enrol. However, you must retake and pass all Unit Tests and the Final Exam at HiHiP before you can apply for the DOH licensure exams.

SATELLITE SECTIONS. Special sections may be organized in an alternate venue that is convenient to a batch of no less than fifteen (15) students. Classes will be conducted by an instructor duly qualified, accredited, and assigned by HiHiP. The aforementioned rules on Registration and Testing shall strictly apply to all satellite students.

GUIDED SELF-STUDY OPTION. If your schedule does not permit you to join any Section, you can avail of the *Guided Self-Study* (GSS) option – provided you have completed at least two years of college education. GSS students need not attend theoretical instruction, but are not exempt from attending weekend hands-on massage training at HiHiP. GSS students are encouraged to enrol with a GSS training buddy for hands-on massage; otherwise, one shall be assigned by HiHiP.

COURSE FEE. The fee is PhP 12,000 for beginners and PhP 9,000 for TESDA NC-II graduates. TESDA NC-II graduates who form a group of ten (10) are entitled to a 40% discount. The course fee does not include make-up/review classes, re-examinations, and the DOH application fee. All payments are non-reimbursible.
